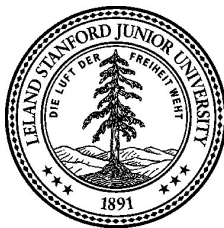

Registration is required for the term in which a student submits a dissertation or has a degree conferred. Students who meet all the following conditions are eligible to be assessed a special tuition rate for the quarter in which they are receiving a degree:

1. All course work, degree requirements, and residency requirements have been completed; graduate and professional students must have enrolled in the applicable 801 or 802 section relevant to their degree during the Graduation Quarter.
2. The student has formally applied to graduate via Axess.
3. The student has filed all necessary forms regarding Graduation Quarter before the first day of the term chosen as the Graduation Quarter.
4. A graduate or professional student must have an active program status, which may include an approved leave of absence, in the term immediately preceding the term chosen as the Graduation Quarter (not applicable for undergraduates).
5. The graduate/professional student has only to submit the dissertation/project or Master's thesis by the deadline for submission in the term designated as the Graduation Quarter (not applicable for undergraduates). *Or*, if enrolled in a joint degree program, the student will complete all requirements for the joint degree by the end of the term designated as the graduation quarter.

Students on Graduation Quarter are registered at Stanford and, therefore, have the rights and privileges of registered students. There is a registration fee of \$100 for the Graduation Quarter, students will be assessed University health insurance (unless waived) and ASSU fees.

Only one Graduation Quarter may be requested. Students who, for whatever reason, are not graduated during the Graduation Quarter will be assessed a higher, standard tuition rate in subsequent terms.
